

## **Privacy Policy**

This privacy policy sets out how Jellybeans Music uses and protects any information that you give Jellybeans Music when you use this website.

Jellybeans Music is committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using this website, then you can be assured that it will only be used in accordance with this privacy statement.

Jellybeans Music may change this policy from time to time by updating this page. You should check this page from time to time to ensure that you are happy with any changes. This policy is effective from 1st April 2018.

### *What we collect*

We may collect the following information for the following reasons:

- Names parent/carer and child - We want to be able to say 'hello' using your name
- DOB child - We want to be able to sing 'Happy Birthday'
- Health conditions - It is important to us that our classes are a safe environment for all participants so we ask to be made aware of any related conditions eg allergies, developmental issues that your child might have
- Emergency phone contact - If we ever have to cancel a class, we want to be able to contact you so you don't have a wasted journey
- Photo permissions in class - We see some amazing moments in class & we'd like to be able to capture them for you
- Email address - We use email to send booking confirmations, class times, dates and cost classes and how to pay. We may also send you newsletters and information about up and coming events or new classes

### *What we do with the information we gather*

We require this information to understand your needs and provide you with a better service, and in particular for the following reasons:

- Session Planning and ensuring that all children are booked onto a developmental appropriate class
- Health and safety
- Child protection reasons
- Internal record keeping

We may use the information to improve our products and services

We may periodically send promotional emails about new products, special offers or other information which we think you may find interesting using the email address which you have provided

From time to time, we may also use your information to contact you for market research purposes. We may contact you by email, phone or mail. We may use the information to customise the website according to your interests

### *Security*

We are committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online.

### *How we use cookies*

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used. This helps us analyse data about webpage traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.

Overall, cookies help us provide you with a better website by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.

You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. This may prevent you from taking full advantage of the website.
