

HULLABALOO PUPPETS Privacy Policy

Welcome to HULLABALOO PUPPETS! We invite you to read this privacy policy, which explains our privacy practices and how we treat your information. It describes the types of information collected and created in connection with your use of HULLABALOO PUPPETS, how and why we use such information, who we share it with and your legal rights. Unless indicated otherwise, this privacy policy ("Policy") applies to all our website, products, services and features (the "Services").

This Policy has been written in accordance of the 1998 Data Protection act and updated in accordance with the requirements of EU General Data Protection Regulation (GDPR) effective from 25th May 2018.

What is HULLABALOO PUPPETS?

HULLABALOO PUPPETS is a preschool musical puppet storytelling company which uses Companies such as Happity and Hoop to list activities and classes for the under-5s; it's aimed at Parents and Legal Guardians looking for activities to do with their babies and toddlers. Our goals are to support parents in their early years of parenthood

We use "Hullabaloo Puppets" here to refer to our website and our services offered as part of that website. We also use "Hullabaloo Puppets", "we", "us" and "our" to refer to the companies operating our website and services. We use the term "Class Providers" to describe ourselves and "Parents/Legal Guardians" are the public audience we are providing a service to, and in general, anyone using the website and reading this Privacy Policy is "you".

Who provides the Services and controls my information?

Hullabaloo Puppets is operated and provided to you by Kate de Freitas. For the purposes of EU data protection law, Kate de Freitas is your data controller and data processor.

The Information we collect

Personal Information

Hullabaloo Puppets may collect and use the following kinds of personal information from you and with your permission:

Parents/Legal Guardians:

- Information that a Parent/Legal Guardian provides for the purpose of registering with Hullabaloo Puppets /Happity/Hoop for booking classes (name, email, address, phone)
- Parents/Legal Guardians login details (username and password)
- Information that Parents/Legal Guardians provide when subscribing to a newsletter (name, email and postcode)
- Information that Parents/Legal Guardians provide when booking a class through Hullabaloo Puppets/Happity/Hoop (name, email, phone, child's name, child's age, child's gender, any other useful information (eg allergies))
- Stripe account reference number of Parents/Legal Guardians if paying for classes through Happity /Hoop booking system

How we use your information

Hullabaloo Puppets may use the information it collects to:

- Provide a secure web account to Parents/Legal Guardians where they can book classes
- Personalise the website for Parents/Legal Guardians who are searching for classes;
- Send Parents/Legal Guardians a newsletter if they have consented; and
- Provide third parties with non-identifiable statistical information about our users.

Data about minors (under-16's)

When a Parent/Legal Guardian books a class, we ask you to provide some details about the child. This information is for the purpose of ensuring that the class is within the specified age range for the class, for tracking payment and to create a class register. We or they do not communicate directly with the minor through the website. The information is provided with the consent of the Parent/Legal Guardian. Class Providers will have consented to our [Terms of Service](#) for using the booking system which outlines their responsibility in keeping this information secure.

Our legal bases for collecting, using, sharing and otherwise processing your information

Hullabaloo Puppets will only collect, use, share, and otherwise process the information we have about you for the purposes described in this policy where legally permitted. These legal bases include:

- For Hullabaloo Puppets to comply with a legal obligation, a court order, or to exercise and defend legal claims;
- For Hullabaloo Puppets to comply with a contractual obligation with you
- Where you have made the information manifestly public;
- Where you have given consent; and

- Where necessary for the purposes of Hullabaloo's or a third party's legitimate interests.

Legitimate Interests include:

HullabalooPuppets legitimate interest in processing your data are:

- To keep Class Provider data up to date for the benefit of Parents/Legal Guardians;
- To improve and develop our services for Class Providers; and
- To provide a seamless experience when you join Hullabaloo Puppets as Parents/Legal Guardians

Your Rights

You benefit from a number of rights in relation to your information that we process. While some of these rights apply generally, certain rights apply only in certain limited cases. We describe these rights below.

Request Access.

Parents/Legal Guardians who require additional information, email us at hullabaloopuppets@gmail.com to request a copy of your information. Where legally required, we will provide your information in an easily accessible format and assist in transferring some of this information to third parties.

Rectify, Restrict, Limit, Delete.

You can also rectify, restrict, limit or delete much of your Hullabaloo Puppets information by emailing us at hullabaloopuppets@gmail.com and we will rectify, restrict, limit or delete your information as requested.

Object.

If we process your information based on our legitimate interests explained above, or in the public interest, you can object to this processing in certain circumstances. In such cases, we will cease processing your information unless we have compelling legitimate grounds to continue processing or where it is needed for legal reasons.
