### **What Information We Collect**

When you book or attend a session, we may collect the following personal data:

- Your name and contact details (email, phone number)
- Your child's age
- Details of your child's needs (where shared)
- Medical or allergy information (where applicable)

- Emergency contact information
- Consent preferences (e.g. photo consent)

#### **How We Use Your Information**

We use the information you provide to:

- Process bookings and manage attendance
- Ensure the safety and well-being of participants
- Tailor sessions to your child's needs
- Communicate with you about session updates, cancellations or changes
- Respond to enquiries or concerns
- Where consent is given, to use photos for promotional purposes

# **Legal Basis for Processing**

We collect and use your data under the following lawful bases:

- Contract: to provide the service you've booked
- Consent: for optional uses like photography or marketing
- Legitimate interest: to ensure the smooth running of sessions
- Legal obligation: to comply with safeguarding and health & safety requirements

### **How Your Information Is Stored**

- Your information is stored securely, either electronically (password-protected) or in locked paper files.
- We retain your data only as long as necessary for the purpose collected, typically no longer than 12 months unless required for safeguarding or legal reasons.

## **Sharing Your Information**

We will never sell or share your information for marketing purposes.

We may share limited information:

• With emergency services if needed

- If required by law or safeguarding regulations
- With trusted staff or volunteers who help run the sessions (on a need-to-know basis only)

### **Photography and Media**

Photos may be taken during sessions for promotional purposes, but only where you have provided explicit consent.

You may withdraw consent at any time by contacting us.

### **Your Rights**

You have the right to:

- Access the information we hold about you
- Correct inaccurate or incomplete information
- Request that we delete your information
- Withdraw consent where given
- Object to certain types of processing
- Lodge a complaint with the ICO (Information Commissioner's Office)
