Who We Are

Fidget and Spin is a sensory stay-and-play club for children aged 2–6, based in Brighton & Hove.

What Personal Data We Collect

We may collect the following data through our website, booking forms, or membership platform:

- 1. Parent/carer name
- 2. Email address
- 3. Child's name and age
- 4. Emergency contact info
- 5. Child's preferences or needs (e.g., dislikes loud noise, non-verbal, sensory sensitivities)
- 6. Booking and session history
- 7. Payment details (handled securely via Stripe)
- 8. Marketing Preferences

Some of this information may be classified as **special category data** under UK GDPR if it relates to health or neurodiversity.

How We Use Your Data

We collect this data to:

- 1. Tailor our sessions to your child's specific needs
- 2. Manage bookings, payments, and attendance
- 3. Provide a safe and supportive play experience
- 4. Communicate with you about your session or membership
- 5. Send newsletters, updates, and marketing offers (if you opt in)

We never sell or rent your data.

Legal Basis for Processing

We process your data based on:



- 1. **Consent** when you voluntarily provide preferences or opt-in to marketing
- 2. **Contract** to manage bookings or membership
- 3. **Legal obligation** where required for safeguarding or records
- 4. **Legitimate interest** improving our services and communication

We always obtain explicit consent before processing any special category data.

How Your Data Is Stored

We use secure, GDPR-compliant tools:

- 1. **Softr** (website builder and forms)
- 2. Airtable (for data storage and booking responses)
- 3. **Memberstack** (for login and membership access)
- 4. **Stripe** (for secure payments)
- 5. **MailerLite** stores parent email addresses and sends marketing/newsletter emails

All platforms have appropriate data protection measures in place.

With your permission, we may use your email address to send:

- 1. Updates about sessions or changes
- 2. Newsletters and educational resources
- 3. Special offers, promotions, or local events
