This privacy policy applies to our use of any and all Data collected by us or provided by you in relation to your use of the Website.

Definitions and interpretation

In this privacy policy, the following definitions are used:

Data – collectively all information that you submit to Sophie Hawkins trading as SHISHU BABY MASSAGE via the Happity Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;

Cookies – a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below (Cookies);

- the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy
