1. Information we collect from you

1.1 We will collect and process the following data about you:

- **Information you give us.** This is information about you that you give us by filling in forms on our site www.gather-ed.co.uk (our site) or by corresponding with us by phone, e-mail or otherwise. It includes information you provide when you register to use our site, subscribe to our service, place an order on our site, participate in discussion boards or other social media functions on our site or when you visit our pop-ups. The information you give us may include your name, address, e-mail address and phone number, details of your child/children, social media handles, financial and credit card information, personal description and photograph.
- **Information we collect about you.** With regard to each of your visits to our site we will automatically collect the following information:
 - technical information, including [the Internet protocol (IP) address used to connect your computer to the Internet, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform;
 - information about your visit, including the full Uniform Resource Locators (URL), clickstream to, through and from our site (including date and time), products you viewed or searched for, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), methods used to browse away from the page.

2. Cookies

1. Uses made of the information

We use information held about you in the following ways:

3.1 Information you give to us.

We will use this information:

1. Disclosure of your information

1. Where we store your personal data

5.1 The data that we collect from you will be transferred to, and stored at, a destination outside the European Economic Area ("EEA"). It will also be processed by staff operating outside the EEA who work for us or for one of our suppliers. This includes staff engaged in, among other things, the fulfilment of your order, the processing of your payment details and the provision of support services. By submitting your personal data, you agree to this transfer, storing or processing.

5.2 We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.

5.3 All information you provide to us is stored on our secure servers. Any payment transactions will be encrypted. Where we have given you (or where you have chosen) a password which enables you to access certain parts of our site, you are responsible for keeping this password confidential. We ask you not to share a password with anyone.

1. Your rights
