

# TERMS AND CONDITIONS

## **Administration and Charges**

All correspondence regarding the commencement or termination of lessons, and related matters, should be addressed to info@musictreeuk.com, and not to the students music teacher or any other staff. Charges for the current academic year can be found <a href="mailto:here">here</a>.

### **Starting Lessons**

Lessons will not commence until Music Tree's invoice has been paid in full. Trial lessons are charged for at the individual lesson rate.

# **Payment**

Fees for each term must be paid in full in advance. They are to be paid directly to Music Tree not later than the first lesson of the term. If payment is not made by this date, Music Tree may, at it's discretion, treat this agreement as having been repudiated

#### Extra lessons

Lessons will be suspended during school holidays and at the usual public holidays. Extra lessons may be scheduled during holiday periods or at any other time by mutual consent. (eg. in order to make up for those missed during the term and/or as extra preparation for external examinations). Extra lessons are chargeable.

#### Cancellation/notice to terminate lessons

MUSIC TREE does not provide refunds for any missed classes. If a student needs to reschedule their lesson they will need to inform the teacher and MUSIC TREE at least 24 hours prior to the scheduled class via email and reschedule according to teachers availability. The rescheduled class date will be decided at the discretion of the Music Tree teachers.

MUSIC TREE students can reschedule 1 missed class per term. Any further missed classes will be charged at the normal class rate. If the student wishes to terminate the classes, 1 half-term advanced notice to cancel must be given in writing to MUSIC TREE. If communication are given less than 1 half-term in advance, Music Tree will charge 2 weeks of classes.

In case of a teacher's absence, the lesson will be rescheduled directly between the family and the teacher. There will be no reimbursement for missed classes.

### Covid-19 T&C

In the event of a government lockdown that forces the closure of the school, your classes will continue online and will be charged as a normal. No classes will be refunded.

# Health and safety

Students under the age of 12 must be accompanied by an adult when arriving and departing the premises. Please make the teachers aware of any medical conditions or special needs that you or the student may have that may be important for the lesson

# PRIVACY POLICY

### WHAT INFORMATION DO WE COLLECT?

# HOW DO WE GET YOUR PERSONAL INFORMATION AND WHY DO WE HAVE IT?

## HOW DO WE USE AND SHARE YOUR PERSONAL INFORMATION?

We may use your information to respond to your requests and provide services. We will only use your information for marketing purposes if you have given us specific and informed indication of your consent for us to do so. We will only use images of you or your child for marketing and/or training purposes if you have given us specific and informed indication of your consent for us to do so. We will not sell, distribute or lease your personal information to third parties unless we have your permission or are required by law to do so.

If you attend a class or event in person on or after the 4th of July 2020 your details will be stored by the class or event organiser and may be shared with NHS Test and Trace or a Public Health Official if they request a list of attendees for that event.
